Information about the collection of data through the use of the websites

When you visit our website, we collect the IP address of your device, the date and time of access, the internet browser used as well as your operating system, your clicking behaviour on the website, your internet provider and the website from which you visit us.

Your personal data will not be passed on by us. We will store your data for a period of 3 months.

We process personal data

- to provide you with this website
- to personalize the Service and provide the content you have selected
- for data analysis
- to prevent and detect security threats, fraud, and other malicious activity
- to comply with our legal obligations and enforce our agreements
- to secure online access

On our website, we use tools for interest-based analysis of user behavior and describe below which technologies we use, why we do this and what this means for you. In order to keep this information transparent and comprehensible for you, we explain in detail in our cookie banner and here where and how your personal data could be processed. By means of our cookie banner, you can make and manage your consents as well as your refusals in a granular way. If you have given us your

consent to the use of cookies, the lawfulness of the use of the data collected in this context is governed by Art. 6 para. 1 sentence 1 lit. a GDPR.

- We use the product Matomo for website analysis. Cookies are used for this purpose, these cookies can be recognized by the name that begins with "_pk". IP addresses of website visitors are anonymized (IPMasking) so that it is not possible to assign them to individual users.
- The playing of YouTube videos or the display of maps requires your consent in accordance with Art. 6 para. 1 sentence 1 lit. a, as personal data is transmitted to YouTube or Google: IP address, information about the browser / operating system used and at least information about which videos or maps you are viewing. As a rule, your data will be transferred to the USA for this purpose. By clicking on "Activate content" on the respective page, you agree to the transfer of your data to YouTube or Google.
- Use of Facebook pixel
Our website uses the "Facebook pixel" of Facebook Ireland Limited, 4 Grand Canal Square, Grand Canal Harbour, Dublin 2, Ireland ("Facebook"). The Facebook pixel can be used to track certain user interactions on our website in order to enable targeted advertising. This is an analysis tool that allows us to measure the effectiveness of our advertising and to tailor our offer to the interests of our users. The Facebook pixel uses cookies and similar technologies to collect information about user activity on our website.
The collected data is transmitted to Facebook in pseudonymised form and stored there. This allows Facebook to link the information collected to users' profiles and use it for its own advertising purposes. The data collected may also be processed on servers outside the European Union. However, there is an adequacy decision by the European Commission in accordance with Article 45 GDPR.
If a corresponding consent has been given, data processing is carried out on the basis of Art. 6 para. 1 sentence 1 lit. a GDPR.
